WHEREAS, surplus fund balances are a common and necessary aspect of the annual municipal budgeting process; and

WHEREAS, in accordance with our auditors' advice and requirements of the NYS Comptroller it is incumbent upon the Town of Colchester to adopt a policy in regard to such fund balances,

THEREFORE BE IT RESOLVED, that the Town Board of the Town of Colchester adopts the following Policy Guidelines:

- A. Fund balances will be appropriated in the annual budget by Board resolution.
- B. Surplus Funds will be allocated to the following Reserve Accounts
 - 1. Repair Reserve Fund Account No. ending in 7554
 - 2. General Capital Reserve Fund Account No. ending in 5558
 - 3. Highway Capital Reserve Fund Account No. ending in 1719
 - 4. Police Vehicle Reserve Fund Account No. ending in 1479

Supervisor Merrill submitted fund balances and recommendations of where to place surplus funds; he explained surplus balances from 2011 to 2016; Supervisor suggests closing out one FEMA Account and leaving approximately \$50,000 in the other FEMA Account, making the new Repair Reserve Fund in the amount of \$2,240,000; he also made the recommendation to add \$450,000 to the Highway Capital Reserve Fund and \$250,000 to the General Capital Reserve Fund. Board discussed.

NO.115-2017 12/20/17 Resolution Establishing the "Repair Reserve Fund of the Town of Colchester" Under Section 6-D of the General Municipal Law

Janet Champlin made the motion, seconded by Julie Markert that the Town Board of the Town of Colchester, duly convened in regular session, does hereby resolve as follows:

SECTION 1. That there be and hereby is established a repair reserve fund in the amount of \$5,000,000 (five million dollars) for future repairs to or improvement of the facilities of the Town of Colchester, including all capital improvements within the Town.

SECTION 2. Such fund is to be known as the "Repair Reserve Fund of the Town of Colchester".

- SECTION 3. That the estimated maximum cost of the said capital improvements or repairs is the sum of \$5,000,000 (five million dollars).
- SECTION 4. That out of the surplus moneys of said Town now on hand for the year 2017 and not otherwise appropriated, the sum of \$2,240,000.00 (two million, two hundred forty thousand dollars) be and the same hereby is appropriated for the "Repair Reserve Fund of the Town of Colchester" and the Supervisor of the Town is hereby authorized, empowered and directed to transfer from surplus funds of said Town the sum of \$2,240,000.00 (two million, two hundred forty thousand dollars) to the fund.
- SECTION 5. Such additional sums as may hereafter be appropriated shall become part of the fund.
- SECTION 6. The moneys in the fund shall be deposited in a separate bank account in Community Bank.
- SECTION 7. The Supervisor, in his discretion, may invest the moneys in the fund in the manner provided in Section 6-c and Section 10 of the General Municipal Law of the State of New York. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become a part of the fund.
- SECTION 8. No expenditure shall be made from the fund except by authorization of the Town Board of the Town of Colchester pursuant to the provisions of Section 6-d and Section 10 of the General Municipal Law of the State of New York.
- SECTION 9. This resolution shall take effect immediately.

Board held discussion; Board discussed moving the ice skating rink due to the fact that the road salt on NYS Highway 30 sprays back and is causing problems; suggested sites were: Covered Bridge Park; vacant Town lot on Main Street next to Dukes and the swimming pool area. Highway Supt. Eck volunteered to get plastic for a new liner and that the Highway would install the rink. Board discussed further and agreed to move to the pool location this year.
